The membership appointed George H. and Lamont D. to officially invite the AA representatives for the Lycoming County Prison, White Deer Run, Williamsport Hospital Detoxification Unit, The Friday Night Big Book Meeting, The Thursday ^{Night} Group which meets at the residence of Bob H. and the Mill Hall Group to attend district meetings.

The group was advised by Denny S. that the Friday Night Williamsport Hospital Group has been changed to a speaker meeting for a (3) month trial basis.

The group was advised by Karyn F. that the Saturday Night YMCA group will be taking a vote to decide on possible relocation.

On February 25, 1982 Denny S. (DMC) will attend the Thursday Night Annunciation Church Group to suggest that they find a new meeting location.

The membership was advised by Lamont D. that Mr. James Cox, a counselor at the Curtin Middle School will be contacting the Williamsport District to discuss plans for a drug and alcohol program for the students at Curtin. The district membership felt that a program of this type would be an asset to our community. Lamont D. volunteered to coordinate this effort when approached by Mr. Cox.

The District's responsibilities to the White Deer Run Treatment Center was discussed. At this meeting no decision on our support for White Deer Run was reached.

A recommendation was made by George H. that the newly formed District support the spring banquet previously arranged by District 42. The entire membership felt that this was the proper action to be taken.


On the agenda for the March 10th meeting we will be discussing plans for the summer picnic - place, time etc.

It was decided that all GSR's of the Williamsport District should provide at the March 10th meeting an up-dated answering service list. It was decided by the district representative that all individuals on the up-dated Answering Service List should have a minimum of six (6) months sobriety and be willing to meet with callers on a 24 hour basis.

At the March 10th meeting discussion will be entertained for the re-organization of the AA Answering Service.

A motion was made by Denny S. to close the meeting, Karyn F. seconded this motion. Meeting was closed with the Lord's Prayer.

DISTRICT 48

District 48 was part of District 42 in the Lewisburg area until 1981, when it split and became District 48. District 48's area consists of Lycoming County and part of Sullivan County. The District has grown from a few meetings to a good number of groups.

By November of 1992, District 48 had grown to 42 groups and maintained several meetings in three different institutions, along with a club house in Williamsport, PA (The 12 & 12 Club).

Currently the District has had 11 DCMs and Alternate DCMs, which are listed below:

History of District 48

Alcoholics Anonymous came to Williamsport in 1943 when an artist named Horace Hand started the Williamsport Group. The nearest meeting at the time was in Harrisburg, and the quickest way to get there was by train. As AA regions developed, District 42 included all groups along the West Branch of the Susquehanna River from Sunbury north to Williamsport. In 1981, the northern section of District 42 split off to become District 48, which covers all of Lycoming County and part of Sullivan County. The first DCM was Denny Sampson, ADCM George Holechek, Secretary Daniel Roupp, and Treasurer Bob Tomke. Today, District 48 is home to some 35 meetings and sponsors meetings in three penitentiaries and several treatment facilities.
